Rules and Regulations for MTS Deepavali Bazaar

- MTS reserves the right to disallow any vendor at its sole discretion.
 - Vendors cannot sub-lease their rented booth.
 - All booth personnel and exhibitors must follow the general instructions given by MTS coordinators.
 - Booth dimensions should not be modified in any form.
 - Displays should not obstruct the view of other booths.
 - No loud music.
 - Vendors must bring their own extension cord; power outlets, etc, for their use.
 - No one will be allowed to sell or distribute any kinds of beverages. Beverages will be sold only by MTS.
- The following additional rules apply to **food booths**:
- Vendor must provide an Insurance Certificate with MTS as the Additional Insured
 - Vendors are responsible for all their permits, etc.
 - Vendor to provide a refundable deposit of \$250/ towards safety and cleaning.
 - Vendors should bring buckets, hand washing/dishwashing soap.
 - Vendors to bring & use hair restraints or caps and aprons for all food handlers.
 - Vendors should bring proper equipment for maintaining the food.
 - Vendors should bring their own ice, if needed for your operations.
 - Bring your own plates, cups and any other products needed for serving.
 - MTS Health Inspection Team will inspect both cooked and uncooked food items for proper adherence to appropriate local, county and/or city health codes. If violations that are brought to the attention of the food vendor are not addressed then MTS reserves the right to close the vendor's booth and no refunds will be made.
